#### RULES OF THE ROAD:

- **Car owners must complete the attached form to participate.** Only those who have properly registered their vehicles will be allowed to participate at the event.
- The Town of Queen Creek will distribute candy to all trunks. No outside candy will be permitted for safety reasons.
- Additional games and activities (e.g., spin wheel) will not be permitted at participating trunks in an effort to keep the trunk line moving.
- A \$25 fee will be charged per registered trunk. A discounted rate is available for additional registered trunks. **Deadline to register: Oct. 8.**
- Registered vehicles may arrive at Desert Mountain Park, 22201 S. Hawes Road, for check-in beginning at 2 p.m. **All trunks must be decorated and staffed by 4:30 p.m.** Trunks arriving after 4:30 p.m. will not be able to participate. The event begins at 5 p.m. sharp.
- **Registered vehicles must stay at the event until the event ends at 9 p.m.** For safety purposes, vehicles will not be allowed to leave the parking lot until the event is over.
- Vehicle owners must show proof of insurance with the vehicle application.
- Registered vehicles will be provided an authorized trunk number upon check in. This number must be placed in a visible location on your trunk.
- Electricity will **not** be available for decorating your vehicle.
