Checks, money orders or cashier checks must be made out to “Town of Queen Creek” and must be received with a completed and signed vendor application. Personal checks must include a phone number on the check and a valid driver’s license number and expiration date in the upper right-hand corner of the check. There is a \$25 charge for all returned checks. **Refunds will not be granted after the listed application deadline date per each event.** All vending spaces are issued on a first-come, first-served basis. Applicants will receive a full refund if not selected. Should refunds be requested from vendors who sign up as a multiple event vendor, the amount refunded will be based on the single event fee as outlined in the vendor application (discounted fee does not apply to refunds). The Town of Queen Creek Recreation Services reserves the right to select all vendors. Applications are due to the Recreation Services office by the initial due date listed for each event. Applications are accepted by mail or in-person. For mailed applications, the postmarked date will be used as the date the application was received. **Faxed and e-mailed applications will not be accepted.**
